JOHN BARNETT, was son of Michael, a wealthy planter of near Camden, Kershaw Co. S.C. also the grandson of Humphrey of near Camden. Humphrey's father was John, his mother was Margaret, their sons: Robert(I) b., 1750, (eldest); Humphrey; Michael, and John.

Robert(I) m., Sarah Love and moved from S.C. to Warren Co. Ga. in 1776; Humphrey went from S.C. to Tenn; Michael died in his native state of S.C. (leaving 2 sons, John and Michael) of which John moved to Post Oak, Bullock Co., Ala; John, son of Humphrey, moved to Washington Co. Ga. where he died heirless.

Robert(I) who m., Sarah Love, Jan. 6, 1798 in Warren Co. Ga. had 3 sons:- Robert(II); Isaac; & John. - Robert(II) is gr-grand father of Caroline Barfield Fulghum, (Mrs. Walter), now living 205 Hines Terrace, Macon, Ga.; John, d., in S.C. 1811; Isaac, m., Miss Clarissa Clark in 1822. Issue: Maggie, Sarah Ann and Robert, (b. 1827 died 1909) Robert married Susie Jones in Wilkinson Co. Ga. in 1846. Had 13 children: Lexington, Josephine, Sarah Jane, Robert Love, (father of Rossie Barnett Benton; Mrs. L.O. Benton, Box 2, Monticello, Ga.); Rossie Ann, Otis, William Dallis, Dollie Bell, Charlie, Obie, Cora Lee, James Wallace and Maggie May. (Both Mrs. Benton and Fulghum were called upon by the writer in March 1946.) Fine cousins.

Michael, was named by his father Humphrey, as Executor with his sister Diana Hester, as Executrix of Humphreys Last Will which was written Dec. 24, 1790 and recorded May 17, 1791 at Camden, Kershaw Co. S.C., Michael's Last Will was written Nov. 8, 1807 and recorded April 3, 1818. Witnesses: Wm. Daniel, Robert Dunlop and Sarah Coates. This Will discloses that Michael's wife was Catherine and that their 2 sons were John, (eldest) and Michael, and 3 dghts: Catherine Barnett, Elizabeth Barnett, and Eliza Barnett. Both Wills well written with a goose quill on large good sheet of paper - ink slightly faded - being well kept but folds showing signs of long wear.

John, s., of Michael, b., about 1775 near Camden, S. C. m., in 1810 Mahala Mothershed, of Welsh descent, likely dght. of Christopher Mothershed, however, William Mothershed lived in same vicinity with no other Mothershed families in S.C. at that time according to 1790 Census. Both Mothersheds had 3 boys, 2 girls and lived just above Camden in Lancaster County.

The stork duplicated to JOHN & MAHALA the same precious gifts presented to the 2 Motherhood families (3 boys, 2 girls). In 1829, John & Mahala Barnett moved their family to Post Oak, Ala. located southern part of Bullock Co. 2 mi. west Inverness.

MICHAEL HUMPHREY, b., July 15, 1812, m., Dec. 20, 1837, Tabitha Ann Dixon, b., Oct. 3, 1820, d., May 1898. They lived 12 years in Bullock Co. then moved to Pike Co. near Kent. He died 1890. He was a prosperous farmer and good man, both he and his wife displayed benevolent dispositions. Both are interred at the Carter cemetery, Briar Hill, Ala. Graves are permanently marked.

In the name of God Amen, the twenty-fourth day of December in the year 1790. Humphrey Barnett, of the State of South Carolina, Camden District, being very sick and weak in body but of perfect mind and memory thanks be to God therefor. Calling unto mind the mortality of my body and knowing that it is appointed for all men once to die, do make and ordain this my last Will and Testament (that is to say) principally and first of all I give and recommend my Soul into the hand of Almighty God that gave it and my body I recommend to the earth to be buried in decent Christian burial at the discretion of my Executors, nothing doubting but at the General Resurrection I shall receive the same again by the mighty power of God, and touching my worldly estate wherewith it hath pleased God to bless me in this life, I give and demise and dispose of the same in the following manner, and form:

I do give and bequeath unto my oldest son ROBERT, (etc.)

I likewise give to my son, MICHAEL one hundred and fifty acres of land off the lower end of the track, by paying out of it one likely Negro Boy or Girl, not under fourteen years of age nor over five and twenty.

And to my youngest son JOHN, I give my wagon, likewise my anvil and hammers and a Bay Mare and Colt, one cow called Spot and her calf, and one cow called Daffy and the biggest bull and one-half of the meat barrows and as for the rest of the hogs twelve months from this date, JOHN is to have two-thirds of them, and one rifle gun and smooth boar.

And to my oldest daughter, Sarah, one negro boy or girl aforesaid that MICHAEL is to pay one cow called "Pretty" and her calf and yearling and "pidy" cow and her calf and one heifer called Browny and spotted heifer and small black heifer and one yearling bull and two of the big Barrows, the beds and household furniture. The bay stallion colt and the old black horse and the one-half of the one-third of the hogs above mentioned when they are divided.

The upper hundred acres of Land I order to be sold and fifty at the Hanging Rock (Branch), and one-third of the price of the above mentioned land, I allow for my second daughter, MARY; one-third of the price of the above mentioned land I give to my third daughter, DIANA, and two of the big barrows and one-half of the one-third of the above said hogs, and one black Mare and colt. And one-third of the price of the above mentioned land to my youngest daughter, ISOBEL.

And I do likewise constitute, make and ordain, MICHAEL BARNETT, Executor, and DIANA HESTER, Executrix of this my Last Will and Testament, etc. etc., I have hereunto set my hand and seal the day and year above written,

WILL OF
MICHAEL BARNETT

In the name of God Amen - I, Michael Barnett, of the district of Kershaw, in State of South Carolina, being very weak and in a low condition but of sound mind and memory, calling to mind the mortality of my body and knowing that it is appointed for all men once to die, I do make, constitute and ordain this my last Will and Testament in the manner and form as followeth:

Firstly, - I leave and bequeath to my eldest son John Barnett the upper part of my tract of land next to Miles Perry, containing five hundred and fifty acres more or less, it being half of my whole tract of Eleven hundred acres to be equally divided to him from the River to the back line, to him and to his heirs and assigns forever.

Secondly - I leave and bequeath to my loving wife Catherine Barnett, the lower part of my land of five hundred and fifty acres more or less - to her during her natural life or widowhood - then and after that term to my youngest son, Michael Barnett, to him and to his heirs and assigns forever.

Thirdly, - My will and desire is that my negroes and stock of every kind should be left together on my plantation until my youngest child becomes of age, - Except any one of my heirs should marry, then and in that case, either of them shall have a horse and saddle, feather bed and furniture chest with drawers and whatsoever can be necessarily spared, at the discretion of my executors hereon and to be deducted from their parts at a final settlement of my personal Estate.

Fourthly, - I leave and bequeath to my three dghts. Catherine Barnett, Elizabeth Barnett, and Eliza Barnett, my whole stock of negroes, except one child, to be equally divided between the three at my wife's decease or when the youngest daughter comes to the age of 18 years.

Fifthly, I give and bequeath to my youngest son, Michael Barnett, one negro child to be pointed out for him at the division of my property by my Executors hereafter.

Sixthly, I leave and bequeath the remains of my stock and household furniture at my wife's decease, to be equally divided between my two sons and three daughters whose names is above mentioned.

Seventhly, I leave my stud horses to be sold to the best advantage and two horses to be purchased for my youngest son, Michael Barnett, out of the money got for him when the said Michael Barnett should stand in need of such horses.

Eighthly, and lastly, I constitute and appoint Thos. Gardner, Esq. and my eldest son, John Barnett, Executors to this my last Will and Testament, disannulling and revoking all other testaments, Wills, Codicils of Wills by me made, ratifying this to be my last Will and Testament.
